

Editorial Policy

The Journal of Northwest Atlantic Fishery Science, published by the Scientific Council of the Northwest Atlantic Fisheries Organization (NAFO) with headquarters at the Bedford Institute of Oceanography, Dartmouth, Canada is intended to be regional in scope, publishing original research papers and notes on Northwest Atlantic fisheries science with emphasis on the environmental, biological, ecological and fishery aspects of living marine resources and ecosystems. Papers of general applicability, methodological papers and review papers relevant to other areas may also be considered. Space for "Letters to the Editor" will also be provided, when necessary, to facilitate scientific discussion of published papers containing controversial aspects. Manuscripts approved for publication are accepted with the understanding that their content is unpublished and is not being submitted elsewhere for publication. All manuscripts should be submitted to the Editor, who, with the assistance of Associate Editors expert in the field of biological oceanography, vertebrate fisheries biology, invertebrate fisheries biology and biomathematics, will ensure that the submitted papers, prior to publication, meet the high standards required for a primary scientific journal.

Background Information

Extension of fisheries jurisdiction by states bordering the Northwest Atlantic resulted in the negotiation of a new convention on multilateral cooperation in the area with regard to fisheries. This Convention, which entered into force on 1 January 1979, established, to replace the former International Commission for the Northwest Atlantic Fisheries, the new Northwest Atlantic Fisheries Organization (NAFO). Consequently, its Scientific Council assumed from the Standing Committee on Research and Statistics of the International Commission for the Northwest Atlantic Fisheries (ICNAF) the responsibility to provide a forum for consultation and cooperation on fisheries science in the Northwest Atlantic.

The Scientific Council considered the establishment of a primary regional fisheries journal essential if its mandate is to be successfully met. Volume 1 of the Journal of Northwest Atlantic Fishery Science was published in December 1980. It is intended that Volume 3 will be published in two issues during 1982. The Scientific Council wishes to encourage both the submission of suitable articles for publication and subscriptions to receive the Journal from interested scientists and libraries of research institutes and universities.
